1) **Warren County Extension Office**, 3132 Nashville Road, Bowling Green, Kentucky 42101 on Tuesday, October 7, 2014 between the hours of 10:00 am and 12:00 pm CDT. (Phone: 270-842-1681)

### **DIRECTIONS**

From Interstate 65: Take exit number 20B onto the Natcher Parkway. Take exit number 6 (the first exit) and turn right onto Nashville Road (31-W) headed northeast toward Bowling Green. Drive about 3/4 of a mile. The Warren County Extension Office will be on the right. It is directly across from Hillvue Heights Church.

From the Natcher Parkway: Take exit number 6 (the third Bowling Green exit) turn left onto Nashville Road (31W) headed northeast toward Bowling Green. Drive about 1/2 of a mile. The Warren County Extension Office will be on the right. It is directly across from Hillvue Heights Church.

2) **Macon Farmers Market**, 2055 Eisenhower Parkway, Macon, Georgia 31206 on Wednesday, October 8, 2014 between the hours of 4:00 pm and 6:00 pm EDT. (Phone: 478-752-1097)

### **DIRECTIONS**

From the North:

I-75 to I-475 to Eisenhower Pkwy (US HWY 80) Exit 3. Turn left onto US 80. Market is approximately 1 ½ miles on your left, just past the Macon Mall. Turn left onto Oglesby Place then take the first road on your right onto the Market property.

From the South:

I-75 North to I-475 to Eisenhower Pkwy (US Hwy 80) Exit 3. Turn right onto US 80. Market is approximately 1 ½ miles on your left, just past the Macon Mall. Turn left onto Oglesby Place then take the first road on your right onto the Market property.

From the East: I-16 West to I-75 south to Eisenhower Pkwy (US 80) . Turn right onto Eisenhower Pkwy. Market is located approximately 2 ½ miles west on Eisenhower Pkwy on your right. Turn right onto Oglesby Place then take the first road on your right onto the Market property.

From the West: Eisenhower Pkwy (US 80) to Macon. Market is approximately 1 ½ miles on your left, just past the Macon Mall. Turn left onto Oglesby Place then take the first road on your right onto the Market property.

### **DIRECTIONS**

I-240 East: Take Exit 5A (Merrimon Avenue). Turn left at the light then left on Woodfin Street. Go 2 blocks, the hotel is on the right.

I-240 West: Take Exit 5A (Merrimon Avenue); left onto Merrimon. Turn left at the second light onto Woodfin Street. Go 2 blocks, the hotel is on the right.
